Chapter 1

General

1-1. History. The Army Medical Command (MEDCOM) Transformation initiative resulted in a fundamental change in the way MEDCOM provides services to the supporting health service area. Because the publication has been extensively revised, the changed portions have not been highlighted.

1-2. Purpose. This regulation defines the health service areas (HSAs) for the regional health commands (RHCs), which includes medical/dental, and public health services. The regulation also:

a. Assigns the RHCs and U.S. Army Medical Department Activity (MEDDAC) HSAs in geographical terms.

b. Provides a list of U.S. Army Medical Centers (MEDCENs) and MEDDACs.

1-4. Explanation of abbreviations and terms. Abbreviations and special terms used in the publication are explained in the glossary.

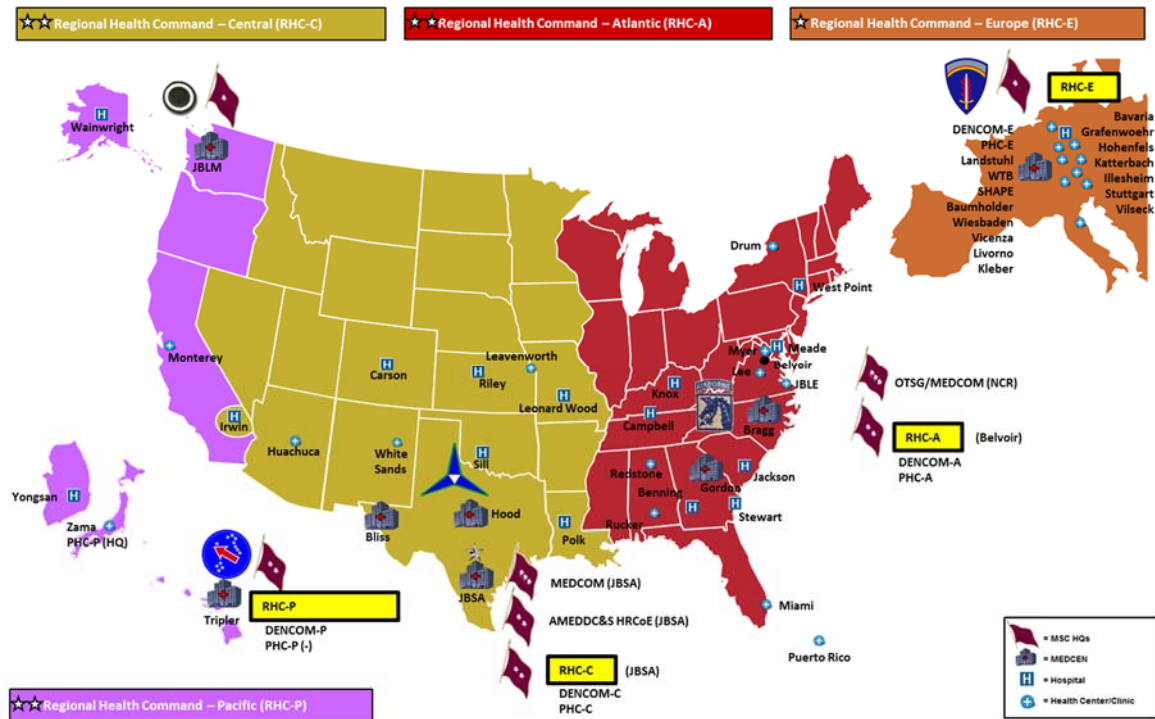


Figure 1-1. Army Regional Health Commands

1-5. Responsibilities. The U.S. Army Medical Command (MEDCOM) is divided into four regional health commands - two in the continental United States (CONUS), and one each in Europe and the Pacific. RHCs are responsible for health services within their region and may adjust HSAs within the region based on capabilities. The area of responsibility for each RHC is shown in figure 1-1 below.

a. If a HSA within a RHC does not have inpatient capability, the RHC will reassign the HSAs responsibility to an MTF that has inpatient capability for the purpose of Absent

Sick tracking within the Patient Administration admission module only. All other management concerns will remain with the original HSA.

1-6. Health service areas (HSAs)

a. The HSA assigned to each MEDCEN, MEDDAC/U.S. Army Dental Activity (DENTAC) is outlined as a geographical area of responsibility in chapter 2. Typically, a RHC consists of two or more HSAs and includes all medical treatment facilities (MTFs)/dental treatment facilities (DTFs) located within the HSA's geographical boundaries. When a complete state is assigned to a HSA, only the state is listed. When a portion of the state is assigned to a HSA, the responsibility is assigned by county or by U.S. Postal Service zip codes when a county is split between two or more RHCs and HSAs. The HSAs' responsibility may also include certain designated semi-active or inactive Federal sites and state operated sites used for annual training of the reserve components.

b. The Dental HSAs are aligned under the RHCs with corresponding HSA boundaries. The DENTAC dental support areas (DSAs) correspond with the MEDDAC HSAs.

c. Veterinary services are provided by the Public Health Activity on a geographical area basis corresponding to the boundaries of the RHC HSAs with minor deviations. The geographical areas of responsibility for the Public Health Activities are contained in USAPHC Circular 40-1.

d. Chapter 3 contains an alphabetical list of states and indicates the responsible HSA for all or part of each state falling within the HSA.

1-7. Military Entrance Processing Stations (MEPS). Chapter 4 contains a list of the MEPS cross referenced with the MEDCEN or MEDDAC responsible for providing medical maintenance and supply support in accordance with the current memorandum of agreement between this command and the U.S. Military Entrance Processing Command (USMEPCOM).

Chapter 2 Regional Health Commands

Section I Regional Health Command - Europe

2-1. Regional Health Command - Europe (RHC-E). The Regional Health Command - Europe coordinates transportation for remote care for U.S. Army personnel and beneficiaries in Africa and Western Asia (West of India) and coordinates/performs Tele-Health capabilities for this same region to include routine military care as well as specialty care. U.S. Navy and U.S. Air Force facilities support Public Health services in certain geographical areas as designated. RHC-E area of responsibility is shown in figure 2-1 below.

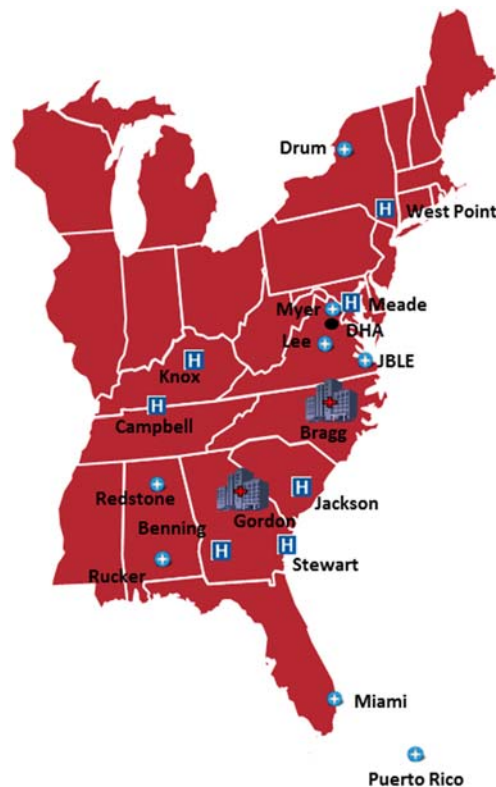


Figure 2-2. Regional Health Command - Atlantic's Health Service Areas

Section II

Terms

Ambulatory Care Center (ACC)

An MTF that is organized, staffed, and equipped to provide preventive, primary, and specialty outpatient services. ACCs may provide acute care, routine ambulatory care, same day surgery, and observation care. Both same day surgery and observation care are generally for care that will be completed within 24 hours. Observation beds are used for care of patients who cannot be cared for on an outpatient status, but who do not require hospitalization. An ACC also provides the full range of ambulatory (outpatient) pharmacy services and limited laboratory and radiology services. ACCs are not subordinate to another MTF. ACCs were previously designated as AHCs.

Army Community Hospital (ACH)

An MTF which provides definitive inpatient care. It is staffed and equipped to provide diagnostic and therapeutic services in the fields of primary care, internal medicine, surgery, and preventive medicine services. An ACH may discharge the functions of an outpatient clinic. The ACH may serve as a specialized treatment or teaching facility when specified in its assigned mission. The ACH is the primary treatment facility of MEDDAC, and will be documented separately on the MEDDAC Table of Distribution & Allowances (TDA).

Army Health Centers (AHCE)

An MTF that is organized, staffed, and equipped to provide preventive, primary, and specialty outpatient services. AHCEs may provide acute care, routine ambulatory care, same-day surgery, and observation care. Both same day surgery and general care will be completed within 24 hours, but may be extended to 48 hours if needed. Observation beds are used for care of patients who cannot be cared for on an outpatient status, but who do not require hospitalization. An AHCE also provides the full range of ambulatory (outpatient), preventive medicine, pharmacy services and limited laboratory and radiology services. AHCEs are not subordinate of another MTF.

Army Health Clinic (AHC)

An MTF designed, equipped, and staffed to provide ambulatory health services to eligible personnel. It normally has general radiology, laboratory, preventive medicine and pharmacy capabilities, and offers specialty care in one or more of the subspecialties of medicine. Services provided depend on the availability of space and facilities, and the capability of the assigned professional staff. An AHC also provides medical, administrative, and logistical functions as directed by the RHC to which it is subordinate and when authorized by the Commanding General (CG), MEDCOM. It may be equipped with beds (normally less than 25) for observation of patients awaiting transfer to a hospital.

These beds are also used for care of patients who cannot be cared for on an outpatient status, but who do not require hospitalization. Such care normally will not exceed 72 hours. When the AHC is also the primary medical facility of the MEDDAC, it will be documented separately on the MEDDAC TDA.

Dental Clinic

A U.S. Army Dental Clinic is a treatment activity or facility that provides diagnostic, preventive, and therapeutic out-patient dental services.

Dental Directorate

The Dental Directorate is aligned under MEDCOM. DENTAC commanders are aligned within their respective RHC. The Dental Director will provide intermediate level of supervision over, and continuous evaluation of, the delivery and quality of dental services provided to eligible beneficiaries throughout their respective region.

Health Service Area (HSA)

A HSA includes medical, dental and public health services in a geographical area which a single MTF/DTF has responsibility for providing designated health care to eligible beneficiaries and medical logistical support. The HSAs will be titled after the name of the installation where the MTF is located.

Health Service Region (HSRs)

The CONUS and certain overseas areas are subdivided into geographic regions. These are designated by the CG, MEDCOM, and overseas commanders. These regions are titled health service regions (HSR). The HSR provide the CG, MEDCOM, and overseas commanders with needed supervision over the delivery of health care to eligible persons within CONUS and overseas. The HSRs are aligned with the respective regional health commands.

Medical Center (MEDCEN)

A large TDA hospital staffed and equipped to:

(a) Provide health care for authorized beneficiaries. Such care includes a wide range of specialized and consultative support for all medical facilities within the assigned geographical area.

(b) Provide specialized medical care to other patients referred to the MEDCEN by appropriate authority.

(c) When designated, conduct post graduate education in health professions.

(d) Serve as a referral hospital, to include laboratory, for the MTFs within its HSR.

(e) Conduct professional training programs as specified in its assigned mission.

(f) Provide administrative and logistical support, as required, to other satellite TDA and table of organization and equipment (TOE) units on the installation. A MEDCEN also performs MEDDAC functions.

Medical Department Activity (MEDDAC)

An organization which includes ACHs, AHCEs, and those AHCs which are not subordinate to another MTF, and which encompass associated activities responsible for providing health services to authorized persons within an assigned HSA. It normally has command and control over AMEDD facilities, activities, or other units (other than TOE units) located within its HSA. The MEDDAC may also be tasked to provide administrative and logistical support to other AMEDD organizations over which it does not exercise command and control. This support may include Army medical laboratories or Army dental activities.

Medical Treatment Facility (MTF)

Uniformed services MEDCENs, ACHs, ACHEs, AHCs, and other facilities that are authorized to provide medical or dental care.

Regional Health Command (RHC)

Holds delegated command and control over the MTFs located within its respective HSR. The RHC will provide intermediate level of supervision over and continuous evaluation of, the delivery and quality of health care provided to eligible beneficiaries throughout their respective Health Service Region (HSR). The RHCs are also responsible for the clinical mission template for the MTFs within their HSR.

Regional Public Health Command (RPHC)

Provides general public health support to forces in their geographical area of responsibility (AOR). This support is executed in accordance with guidance issued by the Commander, Public Health Command, and includes scientific expertise and services in the areas of entomological sciences, environmental science and engineering, occupational medicine, epidemiology and disease surveillance, health physics, health promotion and wellness, laboratory and veterinary services.

Veterinary Treatment Facility (VTF)

A facility which provides veterinary medical support to Government-owned animals, control of animal diseases transmissible to man, and other veterinary services authorized by AR 40-3.
